LIV GARFIELD, CHIEF EXECUTIVE, SEVERN TRENT

Liv is originally from Harrogate in Yorkshire, and is married, with two boys. Liv took up the reins as Chief Executive of Severn Trent, the Midlands-based water and waste company responsible for providing clean water and taking away waste water to around 8m people in the Midlands and mid- and north Wales, in 2014. In October 2020, Liv was appointed a Commander of the Order of the British Empire (CBE) in the Queen's Birthday Honours for services to the water industry.

FIONA THORNEWILL MBE

Fiona Thornewill MBE, broke the world record when she walked solo and unsupported to the South Pole in 2004, this was the first time a woman had physically surpassed a man in polar exploration. She reached the South Pole in 41 days and 8 hours beating the previous record by 3 days. Dealing with crevasses, white outs, a 30-day communication failure and a non-stop 47 mile ski to reach the Pole after her stove failed – Fiona shares how she overcame adversity, loneliness and self-doubt through sheer grit determination to reach her goal. She is also the first woman ever to walk to both the North and South Poles.


SARAH DUXBURY
