Cereal & Vegetable business

- Historically loss making in all previous 5 years when Andersons visited in 2020 (Phase 1 FFRF)
- Strong balance sheet but being eroded and debt growing
- Accounts for Sept YE 2022 show £194,000 profit
- Of, which £100k was reduction in overheads
- New renewables and property project coming on line now could add £50k return after depreciation to the bottom line (albeit a further demand on profit for capital repayment)
- All driven by change in management the next generation;
 but confidence given to the older generation following review process.



Eligibility/ Next Steps

All farmers in England who are in receipt of the Basic Payment Scheme (BPS) and/or have Higher Level Stewardship (HLS) agreements are eligible.
