Smedmore House, one of Dorset's finest Georgian stone manor houses, is spectacularly situated, surrounded by rolling countryside and extensive sea views. The original Grade II\* listed house was constructed in about 1610 and is recorded in a Survey of Dorsetshire in about 1620 as "a little newe house and beautified with pleasant gardens". Around 1700 the Queen Anne garden façade was built and in 1760 two elegant Georgian bays were added to the North West front.

The house is full of interesting contents collected over the years by the Mansel family which include Dutch furniture and paintings inherited from the last English descendant of Godart van Ginkel, Earl of Athlone. In the Front Hall, there is a chair used by Napoleon whilst on St Helena, that was given to Colonel John Mansel who was in the island garrison.

Two acres of walled flower gardens, orchards, and a Mediterranean garden surround the house and at the bottom of the main garden is a path through woods and fields, past sphinxes, urns and obelisks, down to Kimmeridge Bay.

The house is now both the home of the owner, author and historian, Dr. Philip Mansel, and a property that can be rented for holidays, weekends and celebrations. It is also a very popular wedding venue.

One of the main leisure enterprises on the Smedmore Estate is Kimmeridge Bay. It offers opportunities for safe swimming,




rock pooling, canoeing, wind surfing and other water sports. The water visibility is excellent for snorkellers and divers. For surfers, it offers Dorset's premier reef break, Broadbench, which can hold waves of up to 15 feet along with other waves in the "K-Bay" area. There is also a seasonal restaurant, 'The Boat', which is operated in conjunction with Clavell's Restaurant in the village.

The beach consists mainly of rocky shale, with large limestone ledges. It is of great geological interest and the rocks on the beach contain a variety of interesting fossils.

Kimmeridge Bay lies within a Special Area of Marine Conservation with a summer snorkel trail to guide swimmers among the marine life in the shallow waters.

Overlooking the beach is Clavell Tower, a Georgian folly, built on the cliff edge. In 1975, this was the inspiration for PD James's murder story, the Black Tower. It is now available for holiday lets via The Landmark Trust, who moved the tower inland.

# CHAIRMAN'S REPORT - DORSET BRANCH



As competing demands for the use of land multiply, it is not surprising there are renewed calls for a land-use framework. From food production to carbon sequestration, our small island is required to accommodate competing – and not always compatible - claims for space.

Amongst these challenges is mounting pressure for more public access. Some

argue that people cannot be expected to value biodiversity or understand methods of food production unless they are allowed to enjoy unrestricted access to rivers and the wider countryside.

The CLA successfully lobbied to reinstate a cut-off date for ancient rights of way which is now set for January 2031. Meanwhile, Keir Starmer has pledged to introduce the right to roam. In the interests of neuro-linguistic programming, some prefer to use the term 'responsible access'. Providing more space for people to enjoy the countryside is a voluntary option in ELM and FIPYL. The debate is open, and we must ensure that the option to offer more access remains a choice and not a requirement.

Chalk streams are one of Dorset's greatest attributes. The government's provision for chalk streams in the Plan for Water is welcome. Even though Feargel Sharkey, the UK's river champion, is not reassured by what he sees as merely rehashed water plans and promises. It is the third time that removing the plastic content in wet wipes has been pledged.

Water is an emotive and pivotal subject in Dorset. Many CLA members are impacted by a combination of NVZ, catchment sensitive areas, water quality challenges and abstraction implications. In Poole Harbour and the Shapwick and Sturminster Marshall catchments, the deadline for completing the 'clunky' nutrient calculation tool has just passed. Meanwhile the quantities of raw sewage pumped into our rivers by water companies, compounded by the recent oil spill in Poole Harbour, undermine the trust needed to co-operate in tackling the undoubted disaster areas.

Smedmore is one of the jewels of the Dorset coastline looking out towards Kimmeridge Bay. Kimmeridge has always been a beacon of excellent water quality, ranking third in the English clean bathing league. But even here, at the time of writing, industrial plastic

'nurdles' have been swept into the hitherto pristine bay.

- We are very fortunate to be holding our AGM at Smedmore and are indebted to Dr Philip Mansel for his kind invitation. Through generations, Smedmore has navigated inevitable highs and lows. Learning how different land-based businesses evolve and adapt to remain alive and relevant, as Smedmore has, is inspirational as well as an education.
- In response to the CLA's Rural Powerhouse campaign devised to close the productivity gap between town and country £110m has been made available through the Rural Prosperity Fund. £2 million has been allocated to Dorset and members are encouraged to apply.
- There is a paradox: policies that are on the one hand designed to incentivise financial resilience in the rural economy, on the other hand manage to obstruct people's best endevears. A CLA survey of some 600 members found that three quarters had experienced planning objections to business expansion and diversification.
- Planning versus rural enterprise is just one example of the lack of consistent policy. The absence of co-operation between Defra and the Departments of Health and Education is also risible. Henry Dimbleby erstwhile food czar and author of the much-respected National Food Strategy, and now his new book Ravenous resigned his government post so that he could speak out about the damage being wrought by global food giants. Who continue unchallenged profiting, from concocting a bewildering array of ultra-processed products while causing our NHS, and wider economy, to buckle under the cost of diet-related diseases. According to government figures the wider (excuse the pun) costs of obesity to society are estimated to reach £49.9 billion per year by 2050.
- In the immortal words of Wendell Berry: "People are fed by the food industry, which pays no attention to health, and are treated by the health industry which pays no attention to food".
- It has been a privilege to serve as Chairman of the Dorset Branch for the last three years. I applaud the work done by CLA staff nationally and by the Southwest office so ably led by Ann Maidment. Thank you to every committee member for the breadth of knowledge and expertise that you bring to the debate as well as your good company. I am indebted to our President James Weld and Vice Chair Paul Tory for their good humour and support.
