RAMSBURY ESTATE

Ramsbury Estates is made up of 19,000 acres of North East Wiltshire, West Berkshire and North Hampshire, with a large property portfolio. The Home Farms are centered around the village of Ramsbury, which is nestled in the heart of the Kennet Valley. As well as open land, the estate covers more than 2,500 acres of commercial and amenity woodland.

In the early 2000's the estate started to diversify into other rural and business ventures. The brewery was built in 2004 using barley grown and harvested from the estate and following the success of the brewery, a state-of-the-art distillery was built in 2015. The distillery first began distilling its own vodka before adding gin to its portfolio. Thanks to the careful distilling process, high quality ingredients and expertise, Ramsbury produces some of the finest spirits in Wiltshire.

An oil press was added in 2015 to process rapeseed oil onsite. The farming operations centre around arable crops, mainly wheat and barley, alongside a small heard of Aberdeen Angus and South Devon cattle. Produce now ranges from traditionally reared beef, Black Gold rapeseed oil, wild venison and much more.

Spent brewers grains alongside the by-products from the rapeseed is put back into the farm where they are used to supplement the cattle's diet. In addition to making use of its spent grain, waste water is filtered through a reed bed system to sustain a lake for wildfowl and wildlife. Wood from the commercial woodland that isn't used for furniture is chipped and used to heat a biomass boiler to produce hot water and steam.

CHAIRMAN'S REPORT -HAMPSHIRE BRANCH

Welcome to the CLA Hampshire branch AGM 2023.

This marks the end of my first year as Chairman of the Hampshire Branch. It has been interesting and enjoyable to be much more involved with the workings of the CLA at both local and national level, where I also sit on the Environment Committee. It has been a pleasure to work with our excellent South East team headed up by Tim Bamford, who work tirelessly in your interests. I would also like to thank our branch committee for their dedication and support – they cover a huge range of expertise and their incisive analysis often produces unexpected conclusions!

With last summer topping 40C, the heat has certainly been on farming over the past year, while rising energy prices, higher input and raw costs, and labour shortages have meant many rural businesses are being squeezed.

This is a crucial time for the agricultural transition process. At our Rural Business Conference in December, CLA president Mark Tufnell laid bare how rural communities are running out of patience with the government. While some information about payment rates under Environmental Land Management (ELM) schemes was released earlier this year, the CLA will continue to hold the government's feet to the fire to gain further clarity and answers to help members plan for the longer-term.

But the last 12 months has not all been doom and gloom, with a pleasing number of events and in-person gatherings held. One of the highlights was the New Forest and Hampshire County Show earlier this summer, where the CLA teamed up with the National Park to run the tenth annual rural awards. The CLA has also organised agricultural transition and renewable energy events locally, bringing members the latest policy developments from experts. Please do get in touch with the South East office if you need further advice or missed the sessions and require assistance.

The CLA works closely with MPs and Ministers to press home the importance of a profitable and sustainable farming industry. We raise issues with the planning system which are holding rural businesses back, have been calling for a simpler tax regime as well as urging investment in skills and innovation. With a general election likely over the next 12 months, we are also working with candidates and officials from all the major parties to highlight the issues that matter most to members.

Our work on tackling rural crime continued this year, with some notable developments. Tougher sentencing and improved powers for the courts to tackle hare coursing were added to the Police Crime Sentencing and Courts Act 2022. The CLA also joined with local authorities and other professional bodies in a joint letter calling on the Sentencing Council to provide tougher guidance on fines and sentences for culprits of fly-tipping. The government has since committed to reform of the waste industry with increased background checks for firms who move or trade waste, and the introduction of mandatory digital waste tracking.

There will undoubtedly be more challenges to overcome over the next 12 months, and the CLA's role in championing the rural economy and supporting members has never been so important. Please make the most of your membership by using the CLA's brilliant advice service and by attending events and spread the word of the benefits of being part of the organisation.

My thanks, once again, to our South East team for their continued hard work on behalf of us all, and for organising such excellent events, especially this AGM.
