THE BEER QUARRY CAVES

The caves were first excavated by the Romans in around 47 AD. The earliest workings were carried out in open quarries, during which time the estuary of the River Axe provided a safe harbour for the removal of the stone by boat.

Extraction was particularly intense during the Norman and Middle Ages, by which time it was necessary to quarry into the side of the hill because of other rock strata above. Quarry men worked long hours by candlelight with hand tools such as picks and saws. The quarrymen were also often supported by child labour. Skilled stonemasons would then work on the stone in the caves because it became harder to carve when exposed to the air. The stone blocks would then be lifted by hand-operated cranes after the connection of Lewis lifting devices to be loaded onto horse-drawn wagons. They would then usually be taken to barges which would sail from Beer Beach.

Beer stone - a creamy-grey, fine-textured limestone from the Middle Cretaceous period - was particularly favoured for cathedral and church features such as door and window surrounds because of its colour and workability for carving. Stone from the quarry was used in the construction of several of southern England's ancient cathedrals and a number of other important buildings as well as for many town and village churches. Most notably it was used to construct Exeter Cathedral, London Bridge, St Paul's Cathedral, Westminster Abbey and Windsor Castle.

After the Reformation, one of the uses of the caves was as



a secret Catholic church. In the 19th century, the caves were also used to store contraband, including by the smuggler Jack Rattenbury.

Quarrying at the site ceased in the early 20th century when a new quarry was opened nearby. Some caves were then used to cultivate mushrooms and others were used to dump waste from the new quarry.

As well as being open as a tourist attraction, the caves provide a haven for hibernating bats in winter. The presence of the bats, along with the opportunities to see the geological profiles that quarry faces allow, caused the old and new quarries to be declared a Site of Special Scientific Interest. The very rare Bechstein's bat and the greater and lesser horseshoe bats along with five other bat species are all found in the caves.







CHAIRMAN'S REPORT -DEVON BRANCH



As summer rolls into Autumn it is often that time of year when we reflect on the past twelve months and make plans for the future. Whilst we are experiencing some political stability within England at least, there have been challenges for us all, particularly energy prices, input costs and

rising interest rates. There is a sense that these pressures are beginning to ease but it is Impossible to predict whether it will be a sustained downward trend or a short- term valley. We have such limited impact on these external forces that all we can do is ensure that our businesses are in the best possible position to cope with inevitable volatility.

To that end, it is pleasing to see that Defra and the RPA has taken note of the CLA's feedback regarding the Agricultural Transition Plan and particularly the Sustainable Farming Incentive. Whilst not perfect, the 2023 SFI offer is beginning to deliver a scheme which is practical for landowners to access, has straight forward objectives and can be stacked on top of existing agri-environment agreements. It is hoped that as this scheme develops over the next 12 months it will start to replace some of the lost BPS income. particularly in the uplands which has historically been let down by previous schemes. In time it is anticipated that these 'conventional' sources of environmental income will be supplemented by private finance such

as carbon credits and Biodiversity Net Gain but we are not quite there yet. The CLA are continually issuing updates, guidance notes and webinars for these opportunities and so please do keep an eye out for them as these markets start to open up.

As competing demands for land become ever stronger it is likely that future funding sources will be linked to a type of land use matrix, either through Local Nature Recovery Plans or the Land Use Framework. There will be positives and negatives with this approach and so it is vitally important that CLA members engage with any consultations or calls for evidence from the national team to ensure that the diverse views and requirements of Devon's rural businesses are fully represented.

It has been a busy year for the Devon committee members who have reviewed, researched and debated on a wide range of papers from SSSI designations, coastal sea level rise to renewable energy and rural housing. For each topic the members have brought forward their own knowledge, experience and the experience of their neighbours to make sure that the issues affecting Devon are represented at Council. I thank them for the enthusiasm with which they have approached these papers and most importantly their time. I would also like to thank the regional CLA team for their hard work over the last year, particularly delivering another exceptional topical debate at the Devon County Show breakfast. There has been a number of staff changes and I would like to pass on my best wishes to those who have moved on and welcome the new members.
