MONTAGUE FARM

Montague Farm is located on the edge of the Pevensey Levels, with sea views across the habitat rich grassland to the sea. Over 70 years, the farm has been transformed from a derelict site into a thriving 700 acre organic mixed farm buzzing with wildlife. Our kind hosts, Martin and Gundrada Hole, continue the work started by Gundrada's father John Glessing in 1942 and are now supported by their three daughters.

Livestock at Montague Farm includes a flock of Romney Ewes and a herd of cross bred cows alongside the start of a pedigree Sussex herd, all benefiting from grazing on the rich grassland and flat wetlands of the Pevensey Levels.

Nature conservation lies at the heart of the Montague farm business. Montague Farm forms part of the Pevensey farmers group, a cluster of over 50 members spanning 5000 hectares. The cluster priorities continue to support over 216 bird species that have been recorded across the farm, including Snipe, Lapwing, Teal, Turtledove, Redshank and Shoveler. Insect species abound with the rare Fen Raft spider and diverse plant species are found both in the wetlands and in the grassland including green winged orchids.

The 18th century complex of homes, courtyards and barns remains the heart of the farm, still used predominantly for livestock, the business has also diversified into corporate events and weddings, hosts for the East Sussex Pony club and glamping.

CHAIRMAN'S REPORT - SUSSEX BRANCH

The CLA is busy engaging with politicians and candidates of all parties, in order to influence their manifestos and help shape the narrative about how the countryside is governed.

This is my first AGM as your Chairman. For those who don't know me, my name is Annie Brown and I succeeded Francis Hampden in the autumn. I am a third generation family farmer, running a 1,500-acre mixed farm on the South Downs just north of Brighton. I took over the running of the business with my sister in 2007, farming a traditional mix of rotational arable, extensively grazed suckler cows, keep sheep and a small herd of Bagot goats for conservation grazing, all underpinned by a comprehensive environmental stewardship scheme. We also have a small bespoke glamping site, Foot of the Downs, and are planning to open workshop spaces and a learning facility to boost engagement with the public.

There will undoubtedly be more challenges to overcome this year, but you can rest assured that the CLA will continue to be on your side. Welcome to the CLA Sussex branch AGM 2024.

The last 12 months have been challenging for many farmers and rural businesses, with rising costs and a tough economic climate, but the year has also shown the continuing resilience of our sector.

The CLA has been active in pressing Government to recognise the importance of the rural economy and its dynamic qualities. The success of our approach was underlined by its "Unleashing Rural Opportunity" policy paper, which adopted many of the proposals put forward by the CLA's Rural Powerhouse campaign. For example, changes in permitted development rights that introduce much needed flexibility for rural businesses, and definitive deadlines for digital connectivity procurement constitute two major wins for the CLA.

The farming sector faced volatility on numerous fronts in 2023, from the continued unpredictability of grain prices to the ever-changing extreme weather patterns making harvest a challenge. Following the heatwave of 2022 it was the wet weather that dominated farmers' thoughts during the 2023 summer, with further heavy rain and flooding in the autumn.

It has been another busy year for England's agricultural transition as the industry moved into the implementation phase of the new farming policy. While it is positive that such a wide range of initiatives are being funded, getting to grips with the multiple schemes on offer and determining which options could be of interest to each business is not straightforward.
